Per Governor Baker-March 10, 2020-Order Suspending Certain Provisions of the Open Meeting Law, M.G.L. C30A, S20 allowing a Public Body to Conduct its meetings in a public place that is open and physically accessible to the public, provided that the public body makes provisions to ensure public access to the deliberations of the public body for interested members of the public through adequate alternative means. Adequate, alternative means of public access shall mean measures that provide transparency and permit timely and effective public access to the deliberations of the public body. Such means shall include, without limitation, provided public access through telephone, internet, satellite enabled audio or video conferencing, or any other technology that enables the public to clearly follow the proceedings of the public body while those activities are occurring. Where allowance for active, real-time participation by members of the public is a specific requirement of a general or special law or regulation or a local ordinance or by-law, pursuant to which the proceeding is conducted, any alternative means of public access must provide for such participation.
