Vice Chair Panetta stated that is something we should do between us. A Taste for Education is something else to be discussed.

Selectmen Riley thanked the Saugus Police Department for several issues that occurred recently.

Chairman Cogliano stated that ornaments were placed on the Christmas Tree Lighting celebration were the late Cam Cicolini, Wendy Reed, Theresa Whittredge, and Greg Nicholas. Chair Cogliano continued: "I meant no harm nor disrespect to anyone regarding the placement of the ornaments. Two more were added: the late Arthur Gustafson, and Kim Rossi, I never

meant to slight anyone and next year we will plan carefully to make sure everything is done in a proper manner. "


The Saugus Board of Selectmen first thanked the community for re-electing them and wished a Merry Christmas and Happy New Year to all!
