Board of Selectmen Meeting, March 1, 2022 7:00 PM

Chairman Anthony Cogliano called the meeting to order. Also present were Vice Chair Debra Panetta, Selectmen Corinne Riley, Jeffrey Cicolini, and Michael Serino. Chairman Cogliano asked for everyone to stand and recite the Pledge of Allegiance.

Selectman Riley offered a moment of silence for those in Ukraine and to keep those suffering throughout their country.

Chairman Cogliano read a letter from Building Inspector Dan Kelly regarding the Cease and Desist issued at 180 Central Street, Saugus, MA. (Attached).

Mrs. Elizabeth Dormer spoke in opposition to the project. Chairman Cogliano stated the Board has nothing to vote on at this time. Town Manager Crabtree advised the Board to send her letter to the Planning Board.

Selectman Serino stated 180 Central Street needs to return to the Conservation Commission. The town manager said his office will reach out to the Dormer's. Selectman Cicolini moved to refer the letter to the Planning Board. Chair seconds, motion passes 5-0.

Citizens Comments: None

Selectmen Cicolini made a motion to continue the Kowloon public hearing and meet with the Planning Board prior to the selectmen's meeting on March 22, 2022. He stated: "At the Planning Board meeting we will discuss and vote on the Height Restriction variance request at that time." Selectman Riley stated the Planning Board meets on Zoom and would the Board meet informally/separately and if it is an informal meeting why would it be a Planning Board meeting? Selectman Cicolini requested the town engineer be present, and questions will be answered. Chair seconds; all in favor - motion passes 3-2; one no and one abstention.

Two-minute recess.

Public Hearing: North Shore Autobahn. Lawrence Nagle, 91 Broadway, requesting a Class II auto License. Selectman Cicolini moved to allow the petitioner to withdraw without prejudice, chair seconds, all in favor; motion passes 5-0.

Public Hearing: Rarrpo Corporation, Saugus Roast Beef and Seafood, 304 Lincoln Avenue for a common victualer's License. Mr. Rarrpo requested a continuance. Selectman Panetta moved grant the request. Chair seconds, all in favor, motion passes 5-0.

Public Hearing ATCK Fitness. 880 Broadway, hours 5:30 to 9:00 PM. Selectman Cicolini moved to close the hearing. Chair seconds, motion passes 5-0. Selectman Cicolini moved to grant the request of extended hours of 5:30 AM to 9 PM Monday through Saturday. Chair seconds, motion passes 5-0.

Chairman Cogliano will meet with Mr. Crabtree to schedule a meeting.

Town Manager Report: Budget processed has begun and the Finance Committee is meeting on March 9, 2022, at 7 PM in the Conference Room.

Update: Water break at Belmonte School recently with heavy damage.

Pleasant Ave: Building Department working with town's attorney for a Cease-and-Desist letter.

Also, regarding the contractor's yard at 132 Main Street. Mr. Crabtree stated that he asked town counsel to draft a procedure when a Cease and Desist is not complied with and what the next steps would be to move forward with legal action for a resolution.

Approval of Minutes. Selectman Panetta moved to table Minutes.

Members Comments: Selectmen thanked the DPW, contractors and town manager for the good work of plowing the streets during the recent storm. Selectman Cicolini stated that the traffic signs at Highland and Pearce need to be modified which may require a new public hearing. Town Manager Crabtree said the DPW director drafted a map and sent it to the police.

Selectman Riley asked for a date regarding the Master Plan. Selectman Panetta stated the Master Plan is ready and Chris Reilly will be meeting with the town manager. A meeting will be held in a couple of weeks.

Selectman Riley asked about the Capital Improvement Plan Review meeting. Town Manager stated that he has some one reviewing the cost estimates because of the Voke School lead time for costs and will obtain realistic figures as previous costs were underrated.

All selectmen, town manager, and others present, offered their prayers to the people of Ukraine.

Chairman Cogliano s congratulated Detective James Donovan on his retirement and a Citation was issued by the board.

Selectman Panetta moved to adjourn, chair seconds – motion passes 5-0. Time 9:05.
