The Chair said Selectman Mitchell was unable to attend due to a previous commitment.

Selectman D'Eon moved to take Member's Comments out of order. Chair seconds 4-0.

Member's Comments:

Selectman D'Eon announced Boy Scout Troop 62 Christmas Tree lot is open; and said she enjoyed SHS Football & Cheer pancake breakfast; and wished her son Jake a happy birthday.

Selectman Brazis wished everyone a happy Thanksgiving; and happy birthday to Jake.

7:50 PM public hearing for the purpose of determining the percentage of local tax levy FY 2019 to be borne by each class of taxable property within the Town of Saugus

Chairman of the Board of Assessors Michael Serino was present with Board Member Dan Kelly and Deputy Assessor Ron Keohan and presented presentation with options noting the Board historically has supported shifting the tax burden onto Commercial, Industrial & Personal Property for the lowest tax burden to residential. The Chair thanked him for the presentation and asked if the proposed 60 cent increase includes the school project. Mr. Serino said it includes around \$65 million of the project. The Manager explained the project total cost was approved at \$186 million and will be looking to borrow full amount to lock in interest rates. The Chair said it's important the public understands. The Manager explained MA allows a 2 ½% increase, plus debt exclusion & valuation increase. The Chair asked if the presentation will be posted on the website. Mr. Serino said they always do.

Any to speak in favor or opposed? None.

Selectman Cicolini moved to close the hearing. Chair seconds 4-0.

Selectman Cicolini moved the Board vote to shift to the maximum of 175% and adopt a minimum residential factor of 82.6862%. Chair seconds 4-0.

The Manager said its important to mention the commercial taxpayers not only helping tremendously with capital projects but also helps keep residential rate lower and that should be recognized.

Selectman Cicolini said if you look at option for flat tax rate would be \$14.74, then residential is saving \$2. Per \$1,000 evaluation, so the shift alone saves.

Citizen's Comments None.

Selectman Brazis moved to adjourn. Chair seconds 4-0. Meeting adjourned at 8:14 PM.
