The Saugus Board of Selectmen met on March 6, 2019 at 7:00 M in the Town Hall Auditorium, 298 Central Street. Present: Selectmen Scott Brazis, Jeffrey Cicolini, Jennifer D'Eon, Mark Mitchell and the Chairman Debra Panetta.

The Chair said the Manager was unable to attend due to a family commitment.

Correspondence:

1.) Police Dept. re: recommendation to post "No Outlet" sign on Homeland Avenue.

Lt. Art Connors was present and explained request and recommendation.

Selectman Cicolini moved to accept the police recommendation and approve the installation of a standard "No Outlet" sign (W14-2) at the corner of Water Street and Homeland Avenue. Chair seconds 5-0.

2.) K Pub, 22 Lincoln Avenue re: request to resubmit application to ABCC for reconsideration.

Attorney Richard Magnan, 194 Central Street was present representing 22 Lincoln Restaurant Group and explained they received notification that ABCC required additional information.

Selectman Brazis moved to send application with supplemental information to the ABCC for reconsideration. Chair seconds 5-0.

3.) MassDot letter

The Chair said public safety is a priority of this Board and the administration and they hired a traffic consultant to conduct a comprehensive traffic study and tried to address concerns and said the DOT has denied the request to lower speed limits to 25MPH and read letter. The Chair stated the Board will wait for the traffic study before taking further action and said the Board appreciates input from the public.

Attorney Richard Magnan, 194 Central Street was present with applicant Jeff Floramo and explained request for outside seating area 10' x 24' with 33 seats as depicted in the plan submitted and said the fire dept. is recommending bollards be installed and the health dept. The Chair asked if 33 seats. Attorney Magnan described 6 tables and a countertop with 9 stools. Selectman Cicolini said his concern is for ample protection. Attorney Magnan said before they install them they will get fire dept. approval. Selectman Cicolini asked about outside hours. Mr. Floramo said the same as restaurant, but seasonal. Selectman D'Eon asked if they are agreeable to fire dept. conditions. Attorney Magnan said yes. Any to speak in favor or opposed? None.

Selectman Cicolini moved to close the hearing. Chair seconds 5-0.

Selectman Cicolini moved to grant the request of J. Flo, LLC d/b/a Rt 1 Grillhouse, 817 Broadway, for alteration of licensed premises and change in description of the All Alcoholic Common Victualer's License by allowing a 10' x 24' outdoor dining area with 6 tables and countertop and no more than 33 seats, with no smoking and working with the fire dept. will install barrier along the boundaries to the satisfaction of the fire dept.; hours to be the same 11am to 12:30 am.
