The Saugus Board of Selectmen met on June 25, 2020 at 7:00 PM via video conference. Present were: Selectmen Jeffrey Cicolini, Debra Panetta, Corinne Riley, and the Chairman Anthony Cogliano. Absent: Selectman Michael Serino.

1.) Discuss dates and call for a Special Town Meeting.

Articles previously inserted into the next Special Town Meeting Warrant.

The Chair said he discussed with the Moderator and is comfortable with July 13th by Zoom video conference and said he understands some Town Meeting Members are not happy about remote meetings, but speaking with Town Counsel, still feels it's the best way to go and side by safety. Selectman Cicolini noted spikes in cases in other states and if there's a way to do it without spreading.

Selectman Panetta moved to call a Special Town Meeting to be held remotely on July 13, 2020 at 7:30 PM. Chair seconds 4-0.

Selectman Panetta moved to insert all the non-financial Articles into the previously inserted and then removed from the Annual Town Meeting Warrant, into the 7/13/20 Special Town Meeting Warrant. Chair seconds 4-0.

1.) Mr. Peixoto re: request for Block Party Permit for Wedding.

Carlos Peixoto was present on video conference and explained request. The Chair asked if he spoke with police yet. Mr. Peixoto said no, only the fire. Selectman Panetta said he has already read and agrees to the standard conditions and read. Mr. Peixoto agreed. Selectman Riley confirmed they had Fire Dept. recommendation.
