The Saugus Board of Selectmen met on December 13, 2017 at 7:30 PM in the Town Hall Auditorium, 298 Central Street. Present were: Selectmen Scott Brazis, Jeffrey Cicolini, Jennifer D'Eon, Mark Mitchell and the Chairman Debra Panetta. The Town Manager Scott Crabtree was also present. <u>Correspondence:</u>

1.) SCTV re: presentation & approval of budget.

Al DiNardo, President of SCTV, 199 Essex Street was present with Treasurer Fatima Allan, 42 Evergreen, Vice President Donna Sordello, 6 Guard St Ext., and Executive Director Bryan Nadeau. Mr. DiNardo said SCTV has voted its first complete budget for 2018. Ms. Allan read budget request. Mr. Nadeau explained replacement equipment needed and other needs. The Chair asked if equipment had salvage value. Mr. Nadeau said they have inventory with no value at this time but will evaluate when they plan for updates / upgrades. The Chair said they did an excellent job putting it together and asked about capital. Mr. Nadeau explained equipment that hasn't been replaced or upgraded in years. The Chair asked about insurance. Mr. Nadeau said they have all required under the agreement with the Board. Selectman Cicolini pointed out an adjustment needed in total budget and asked if they are projecting out 3% raises. Ms. Allan said up to 3% depending on evaluations. The Chair asked number of employees and 5 full time and 1 part time. Mr. Nadeau said 4 full time.

Selectman Cicolini moved to accept the presentation and approve calendar year 2018 SCTV budget with adjustment. Chair seconds 5-0.

Mr. DiNardo said they have stabilized the budget and going forward due to the demolition of the high school, their next major task is to find a new location and it would probably take a year to build out new studio with long overdue upgrades. The Chair thanked SCTV for covering Town events.

2.) Border Café, 356 Broadway re: request for change of manager TO: James Hyson.

James Hyson, 8 Smith Road was present. The Chair asked his experience. Mr. Hyson gave his background and experience. The Chair noted he is TIP certified and pointed out he has worked at 6 different restaurants in 6 years.
