The Saugus Board of Selectmen met on January 7, 2020 at 7:00 PM in the Town Hall Auditorium, 298 Central Street. Present: Selectmen Jeffrey Cicolini, Debra Panetta, Corinne Riley, Michael Serino and the Chairman Anthony Cogliano.

The Board held a moment of silence for the passing of the Town Manager's father Allan Crabtree and for long time employee Ralph Materese and offered condolences to their families.

The Chair said the Town Manager was not present and sent his best to his family.

Correspondence:

1.) Police Dept. re: request for "Dead End" sign on Bridge Street.

No one was present.

Selectman Panetta moved to approve the request per the recommendation of the police dept. Chair seconds 5-0.

2.) Knights of Columbus annual Beano Report.

No one was present.

Selectman Panetta moved to accept the annual beano report from the Knights of Columbus. Chair seconds 5-0.

Continued Hearings:

1.) VDT Salons, LLC for Special Permit (S-2) to allow salon offering nails, facial and waxing services, to be located at 600 Broadway, Assessor's Plan 1048, Lot 15.

Anthony Tran, 5 Water Wheel Lane was present. The Chair said when he was last before the Board he was asked to meet with Inspectional Services. Mr. Tran said he met with the Plumbing Inspector and Mr. Varone (Building Commissioner) and said Mr. Varone denied him because he doesn't have enough parking spaces and said it would be tough to do business with less stations. Selectman Cicolini asked for clarification that when he met with the Plumbing Inspector & Building Inspector there wasn't enough parking and asked if he's looking to scale down and what his plan is and said for him to vote, he will need an ok from the Building Inspector. Mr. Tran said the number needed to pay rent & utilities and expenses so if he reduces he will not be able to take care of costs and he will let this be denied and he is working with the property owner. Selectman Serino said it is better to withdraw the request and reapply. Selectman Cicolini agreed and said if he's working with the landlord. Selectman Serino said the only other option is to approve with less stations. Selectman Cicolini said he would want to see revised plan. The Chair said the Plumbing Inspector said the applicant dropped off something to him and asked if it was a revised plan. Mr. Tran said no. Selectman Panetta agreed it best to withdraw. The Chair said he spoke with the Building Inspector and if they are not taking a smaller space, then they should withdraw and reapply.

Any to speak in favor or in opposition? None.

Selectman Serino moved to let the petitioner withdraw without prejudice. Chair seconds 5-0.

Their clerk reported both Five Guys and Kelly's are paid and is in communication with Best Buy that did send check in December but the Town doesn't have yet and are tracking it down and reported the mall has processed their last payment but tenants still owe just under \$3,000 and are working on that.

Selectman Panetta moved the Board take no action on GFV Holdings LLC d/b/a Five Guys Burgers & Fries, 180 Main St; Kelly's Roast Beef of Saugus, Inc., 595 Broadway because they have paid to the satisfaction of the Collector of Taxes. Chair seconds 5-0.

Selectman Panetta moved to continue the hearing on Mayflower Square One LLC d/b/a Square One Mall 1201 Broadway; and Best Buy Stores, 1201 Broadway based on information received from their clerk. Chair seconds 5-0.
