Citizen's Comments

The Saugus Board of Selectmen met on December 8, 2020 at 7:00 PM via Zoom video conference. Present: Selectmen Jeffrey Cicolini, Debra Panetta, Corinne Riley, Michael Serino and the Chairman Anthony Cogliano.

Correspondence:

1.) Knights of Columbus re: request for change of manager

No one was present. Selectman Panetta disclosed that her husband is an Officer of the club. Selectman Serino moved to grant the request for change of manager. Chair seconds 5-0.

2.) Collector / Treasurer re: request to Review and approve the results of the Town Refunding Bond of the General Obligation Municipal Purpose Bond of 2011.

The Collector / Treasurer Wendy Hatch was present and explained bids were received to refinance debt from 2011 and are looking at 3%-4% substantial savings. The Chair congratulated her. The Manager said it is contributed to our AA+ bond rating that he worked hard to accomplish and said most of the savings will be in water & sewer debt and commended the Town's financial team noting it's all due to the decisions made over the last 8-10 years. Selectman Panetta said Wendy (The Collector / Treasurer), Town Manager, Finance Committee and Town Meeting have made excellent decisions over the years and we are able to save millions of dollars offering kudos to the administration and said she looks forward to continuing strong financials. Selectman Cicolini said it is remarkable to have 5 bidding on bonds and said in 2011 interest rates were over 4% and said hats off to the manager and financial team. Selectman Serino said we have come a long way since 2012 and hired a new manager and put financial policies in place. Selectman Riley agreed and thanked Ms. Hatch & the Town Manager and everyone involved. The Chair said the Manager's job has ups and downs, but he deserves the credit he is receiving tonight. The Manager said it's about educating to make strong financial decisions. The Collector / Treasurer added that there is no additional time on the loan and said she remembers in 2012 going to the State Auditor practically begging to use the State bond rate. Selectman Serino said he was there also. Selectman Panetta said she remembers. Selectman Cicolini said part of the bond rating process is assessing debt and to stay within a healthy range stating surrounding communities' average is 6-7% and we keep a close eye on borrowing and as we bring on debt, we are retiring debt. The Manager said if we had no debt, we would be laying people off to afford to fix a roof.

Selectman Panetta moved the Board vote That in order to reduce interest costs, the Treasurer is authorized to issue refunding bonds, at one time or from time to time, pursuant to Chapter 44, Section 21A of the General Laws, or pursuant to any other enabling authority, to refund a portion of the Town's \$6,163,000 General Obligation Municipal Purpose Loan of 2011 Bonds dated March 3, 2011 maturing on March 1 in the years 2022 through 2031 (inclusive) (collectively, the "Refunded Bonds") and that the proceeds of any refunding bonds issued pursuant to this vote shall be used to pay the principal, redemption premium and interest on the Refunded Bonds and costs of issuance of the refunding bonds.

<u>Further Vote</u>: that the sale of the \$2,015,000 General Obligation Refunding Bonds of the Town dated December 17, 2020 (the "Bonds"), to Robert W. Baird & Co., Inc. at the price of \$2,417,014.92 and accrued interest, if any, is hereby approved and confirmed. The Bonds shall be payable on March 1 of the years and in the principal amounts and bear interest at the respective rates, as follows:

<u>Further Vote</u>: that in connection with the marketing and sale of the Bonds, the preparation and distribution of a Notice of Sale and Preliminary Official Statement dated December 2, 2020, and a final Official Statement dated December 8, 2020 (the "Official Statement"), each in such form as may be approved by the Town Treasurer, be and hereby are ratified, confirmed, approved and adopted.

<u>Further Vote</u>: to authorize the execution and delivery of a Refunding Escrow Agreement to be dated December 17, 2020, between the Town and U.S. Bank National Association as Refunding Escrow Agent.

<u>Further Vote</u>: that the Town Treasurer and the Board of Selectmen be, and hereby are, authorized to execute and deliver a continuing disclosure undertaking in compliance with SEC Rule 15c2-12 in such form as may be approved by bond counsel to the Town, which undertaking shall be incorporated by reference in the Bonds for the benefit of the holders of the Bonds from time to time.

<u>Further Vote</u>: that we authorize and direct the Town Treasurer to establish post issuance federal tax compliance procedures and continuing disclosure procedures in such forms as the Town Treasurer and bond counsel deem sufficient, or if such procedures are currently in place, to review and update said procedures, in order to monitor and maintain the tax-exempt status of the Bonds and to comply with relevant securities laws.

<u>Further Vote</u>: that any certificates or documents relating to the Bonds (collectively, the "Documents"), may be executed in several counterparts, each of which shall be regarded as an original and all of which shall constitute one and the same document; delivery of an executed counterpart of a signature page to a Document by electronic mail in a ".pdf" file or by other electronic transmission shall be as effective as delivery of a manually executed counterpart signature page to such Document; and electronic signatures on any of the Documents shall be deemed original signatures for the purposes of the Documents and all matters relating thereto, having the same legal effect as original signatures.

<u>Further Vote</u>: that each member of the Board of Selectmen, the Town Clerk and the Town Treasurer be and hereby are, authorized to take any and all such actions, and execute and deliver such certificates, receipts or other documents as may be determined by them, or any of them, to be necessary or convenient to carry into effect the provisions of the foregoing votes. Chair seconds 5-0.

Patrick Higgins, Swansea MA was present on Zoom conference representing Burger King and explained the purchase and plan to continue operating with no changes. Selectman Panetta confirmed the hours of operation and number of seats.

Any to speak in favor or in opposition? None.

Selectman Panetta moved to close the hearing. Chair seconds 5-0.

Selectman Panetta moved to approve JSC Broadway, LLC d/b/a Burger King #1560, for transfer of Common Victualer's License from Jan Co Central, Inc. d/b/a Burger King, 1449 Broadway with same conditions: 111 seats; and hours of operation 7 days a week7:00 AM to 12:00 AM with doors closing to the public at 11:00 PM. Chair seconds 5-0

Selectman Panetta noted Stephen Gerome was present on Zoom conference and let him know the Board approved the request for change of manager of the Knights of Columbus. Mr. Gerome thanked them.

Citizens' Comment: None

7:20 PM public hearing for the purpose of determining the percentage of local tax levy FY 2021 to be borne by each class of taxable property within the Town of Saugus.

The Deputy Assessor Michelle Branciforte was present with Assessors David Ricciardelli and Dan Kelly were present on video conference. Assessor Ricciardelli explained presentation. The Chair asked what the shift would be. Mr. Ricciardelli said 175% which gives some relief on residential and keeps the tax rate at a reasonable rate. The Deputy Assessor gave example. Selectman Panetta said every year she has voted the shift and we are fortunate to have a rich commercial base which helps lower he tax rate and said the Board isn't voting the tax rate, but tonight they are voting on the shift. Selectman Serino thanked the Assessors noting if we had a single tax rate it would be \$14.71 and said we have always shifted which allows it to drop to \$12.34 and thanked everyone on their work. Selectman Cicolini said the DOR (Dept. of Revenue) sets the tax rate and said the average increase would be \$307 which includes the debt exclusion which is less than what was projected at the time of the debt exclusion and pointed out neighboring communities 2020 tax rates. The Manager said it shouldn't go unrecognized that commercial taxes support Saugus investments and thanked them. Selectman Cicolini agreed and said the town has 82% residential property & 18% commercial, industrial & personal property, but with the shift they pay 31%.

Selectman Serino moved in accordance with MGL c. 200, the Board of Selectmen vote to shift the town's tax burden from residential to commercial, industrial and personal property 175% and vote an FY2021 minimum residential factor at 0.838936 pending DOR approval. Chair seconds 5-0.

Continued Hearings:

1.) National Grid to construct underground electrical conduit, on Collins Avenue

N. Abata was present on video conference and explained request. Selectman Panetta said the Board received the revised plans and DPW was OK with it. Selectman Serino thanked them for submitting the revised plans.

Any to speak in favor or in opposition? None.

Selectman Panetta moved to close the hearing. Chair seconds 5-0.

Selectman Panetta moved to approve National Grid to construct underground electrical conduit, including necessary fixtures under and across the following public way: Collins Avenue from approximately 450' westerly of centerline of intersection of Broadway and continuing approximately 50' in a southerly direction –installation of 2-4" conduit from pole #7 to proposed MH1 & installation of 2-4" conduit from pole #9 to proposed MH1 as shown in plan #29859292 dated 10/15/20. Chair seconds 5-0.

2.) The Chair asked if there have been any payments. Their Clerk said some are in process, but not received yet. Selectman Serino said they should let Wendy (their clerk) issue the licenses if they submit application and payment is made. Selectman Panetta said the Board could continue the hearing for those who have not paid.

Any to speak in favor or in opposition? None.

Selectman Serino moved to continue the hearing to January 5th and to allow their clerk to process applications if payments are received. Chair seconds 5-0.

3.) Public hearing on amending the Town's Traffic Rules & Regulations Article V, Section 2. Parking Prohibited on Certain Streets: BY designating "No Parking" on Saville Street and Riverbank Road; and on amending the Town's Traffic Rules & Regulations ARTICLE IX, Section 8: "Obedience to Isolated Stop Signs" by posting a "Stop" sign or a "Yield" sign on Riverbank Road at intersection of Saville Street; or any other action the Board may take.

Petitioner Alicha DiTomaso, 6 Saville Street, was on video conference and explained request for no parking signs and for stop sign on Riverbank Rd. Selectman Panetta noted no police at the meeting and said the police are not in favor and hoped to hear what they have to say. Selectman Cicolini said the fire dept. also agreed with police and he would like police & fire present to express their concerns and maybe a compromise. The Chair apologized to the petitioner and send it's in the best interest to continue the hearing. Selectman Serino said he would like to see someone from the police dept. present. Selectman Panetta said she knows the area well and understands concerns but it's important to have police / fire here. Selectman Riley said according to the Nov. 24th minutes it was suggested to continue with police present and asked they know to be here next meeting. Selectman Cicolini suggested their clerk contact them. The Chair said he doesn't understand why they're (police) against it if they are giving out tickets.

Selectman Panetta moved to continue the hearing to January 5th. Chair seconds 5-0.

The Chair said the Board did not close the hearing on the tax classification and asked if anyone was present to speak in favor or in opposition. No one replied. The Manager suggested waiting until the end of the meeting.

Old Business: Cable Studio update

SCTV Director Brian Nadeau was present on video conference with Donna Sordello, SCTV acting President and said they are trying to open to the public but are waiting for fire and explained a couple of issues that needed to be resolved and then the Building Inspector will sign the Occupancy Permit and said they did the final install in the control room. Ms. Sordello gave update on finances and said the fence is a go to install for \$16,000 and the only other issue is the media room at Belmonte about who is going to pay the \$35,000. The Manager asked who approached them. Mr. Nadeau said an engineer working under Kevin Nigro. Selectman Riley asked when they will have occupancy. Mr. Nadeau explained fire issues that needed to be addressed that do have additional cost associated with. The Manager said usually the architect submits plans for approval to fire in advance. Mr. Nadeau said the fire did sign off in advance. Selectman Riley asked how long it will take. Mr. Nadeau said within days and is waiting on final inspections. Selectman Riley asked when the public will be able to watch the meetings

live. Mr. Nadeau said it would be an add-on and if the Board feels they should, it would cost @ \$80.00 a month. Selectman Riley asked if it could be cancelled once zoom meetings stop. Mr. Nadeau said he will look into it. Selectman Riley asked if they were almost ready for construction audit. Mr. Nadeau said yes, as soon as they get certificate of occupancy and finish the punch list and have already started to scan documents needed. Selectman Riley asked the Manager if it would be something that could be put under the CARES Act. The Manager said he would look into it. Selectman Panetta asked if they purchased all equipment needed. Mr. Nadeau said yes, but there may be a few things they get after the new budget. Selectman Panetta asked of the transformer situation. Mr. Nadeau said yes and it was an additional \$5,000. Selectman Cicolini reminded everybody they will need to work with the Manager to start the audit noting the money was already appropriated, and said the audit will give rate payers confidence there was no maleficence and it was done and done right.
