Dear Phase 1, 2, 3, or 4 Business,

On Monday May 18, 2020, the Massachusetts Governor Reopening Advisory Board issued guidance to Local Board of Health's on a "Phase 1" Reopening of Massachusetts as it pertains to opening of business and workplaces. The Reopening Advisory Board list of business included; current essential business already open, manufacturing, construction, retail curbside, places of worship and firearms retailers. <a href="https://www.mass.gov/doc/reopening-massachusetts-may-18-2020/download">https://www.mass.gov/doc/reopening-massachusetts-may-18-2020/download</a>

Under the "Phase 1" before a business (<u>May 18<sup>th</sup></u> Manufacturing, Construction, Retail-Curbside, Places of Worship and firearms/<u>May 25<sup>th</sup></u> Laboratories and life sciences, Offices limited to less than 25 maximum occupancies, Car washes, Hair Salons, Barber Shops, pet grooming and certain outdoor recreational activity) can re-open as long as the business and workplaces adhere to very specific guidelines. These guidelines include mandatory safety standards for workplaces including social distancing, hygiene protocols, staffing and operations and cleaning and disinfecting. Phase 1 business and workplaces must self-certify that they will operate in compliance with the new safety standards and protocols and provide below:

- 1. Develop a written COVID 19 control safety plan outlining how will prevent the spread of COVID19.
- 2. Produce a self certification that will operate in compliance with all applicable and mandatory workplace safety.
- 3. Complete the MDPH workplace safety standard checklist
- 4. Post a series of posters that can be viewed by employees/customers in the workplace.
- 5. Work place safety standards are enforced jointly by local Board of Health's and Division of Labor Standards.
