The SAUGUS ZONING BOARD OF APPEALS will hold a public hearing on **THURSDAY, MAY 23, 2019 at 7:00 pm**, in the **SAUGUS PUBLIC LIBRARY, 295 Central Street** (Meeting in the First Floor Community Room), Saugus. The following petitions will be heard. Petitioner or their representative must be present.

- 1. On the petition of John Frisco, owner of the property at <u>404 Main St.</u>, (Lot #352, Plan #1034) seeking a special permit to build a 40' x 6' farmers porch and a variance for a 22.34' front yard setback where 30' is required.
- 2. On the petition of Cynthia Martinez, owner of the property at <u>5 Willis St.,</u> (Lot #12, Plan #3005) seeking a special permit to build a 15' x 15' tree house and a variance for a 8' front yard setback where 20' is required to Grandview Ave.
- 3. On the petition of Joanne Verrette, owner of the property at <u>23 Juniper Drive</u>, (Lot #585, Plan #1034) seeking a special permit to outfit an accessory dwelling for her mother by adding a kitchen and bedroom in the basement with using part of the garage.
- 4. On the petition of Saugus Avalon LLC for Geico, owner of the property at <u>855</u> <u>Broadway</u>, (Lot #56, Plan #1036) seeking a variance for one additional internally lit, 174" x 27" (29.25 sq. ft.) wall sign, reading Geico, on the rear of the building facing Rte. 1.
