Town Manager speaks at 7:40pm about the Stabilization Fund, putting \$1 Million in free cash. We are still under 10% of our operating budget. No layoffs or interruptions of services like other communities.

Bob Palleschi, Precinct 7 at 7:44pm asks; what are the various areas generating free cash?

Town Manager at 7:45pm answers that it is about \$3.8 million this year from free cash. He reminds Town Meeting those year there was no free cash. Most is from fund balance roll over, expenses, taxes that were collected and spending within our means. Having a good bond rating and financial health.

Martin Costello, Precinct 10 speaks at 7:48pm specifically asking about our bond rating now? What the other 351 cites/towns where are and we top or low 50%

Town Manager states Saugus is AA+ bond rating. There are only a few communities that are a AAA. Tough time to maintain what we have and not being downgraded. Very well respected where we are for our financial health.

Town Manager speaks at 7:58pm, clarification this is a feasibility study and the next stage. Already did feasibility study mainly how long it would take to get there and the need for a fire station on the west side. Addressing the needs of the community, figure out where, look at a site, put a foot print together and look at the operational costs. This will not happen without a debt exclusion or over ride. Public safety is important. This is a next stage to give to the public. Please support the article.

Bob Long, Precinct 9 speaks at 8:02pm this has gone on forever. First duty to the community is public safety. Another feasibility study, talk a lot about it but nothing is done about it. Reads an

article regarding another fire station. In 1995 Town Meeting voted the capital improvement plan which set aside \$500,000.00 for this and it passed.

Martin Costello, Precinct 10 speaks at 8:08pm agree with Mr. Long. How much will this evidently cost? He thinks the Fire Chief should be part of the process with the study committee in what this town needs.

Debra Panetta, Board of Selectmen speaks at 8:09pm, the Board of the Selectmen has made the West Side Fire Station a priority.

Maureen Whitcomb, Precinct 4 at 8:10pm asks when do they plan on doing the feasibility study and how long will this take?

Town Manager speaks at 8:11pm stating as soon as possible. Like the school discussion, need to get real support from the public/community on this issue. Must have a thorough comprehension plan put together like the schools for the community to see exactly what is happening. No politics. Location is the most important. This must be done correctly and experts giving us the best advice.

Chris Riley, Precinct 2 speaks at 8:17pm is in support of the article. Asks will this study include land, location, foot print and operational costs? Will this study include a detailed design? Will this be put in front of voters with models?

Town Manager speaks at 8:19pm doesn't have exact cost, could be more or less. This will give us a footprint to put in front of people and maybe spend more to give more detail.

Chris Riley, Precinct 2 speaks at 8:21pm he is asking to make sure we do the study and you are some thing you want to put in front of the voters.

Town Manager will have a Special Town Meeting right away to get more money but he is confident this is enough money with no interruption in the process.

Peter Delios, Precinct 10 at 8:22pm asks if ever considered peering up with other communities like Wakefield or Melrose to deter some of the funds?

Town Manager speaks at 8:23pm something we can consider and the Fire Chief can speak more on this. Initial thoughts to have our own station and issues. Not sure that is the easiest thing to do and can be more complicated.

Bob Long, Precinct 9 speaks at 8:24pm in 2020 Town Meeting had an article on this subject had a lot of this work already done, with the recommendations in 2021. Take that report issued at the time and used that report.

Town Manager speaks at 8:27pm for clarification the feasibility study that was done by a committee is different, is more action based moving into the area of and the costs associated. This is a different study to alleviate the issue of the response times.

Martin Costello, Precinct 10 speaks at 8:40pm since some of this money used by the DPW, any money used by the snow and ice.

Town Managers states that \$185,000.00 per year is earmarked for snow and ice. The DOR allows for a fiscal deficit for snow and ice. The cost for everything including for snow and ice have considerable increased, like food.

Jean Bartolo, Precinct 6 speaks at 8:43pm asks about the 3 municipal department vehicles, who & where they are going?

Town Manager states not for who they are going to the municipal vehicles. Just hired an Engineer that is using his own vehicle, Assessor that uses own vehicle and Inspector using own vehicle. Liability if they get into an accident in their own car doing town work. Look to see exactly where to put them. Maybe have some "pool" cars.

Jean Bartolo, Precinct 6 are we going to be doing this every year? Money should go to the schools.

Town Manager states Yes. This is a borrowing an article. Schools are an operational budget.
