If you feel you are the owner of abandoned property as your name appears on the list above, simply contact the Town of Saugus Treasurer's Office to obtain an Abandoned Property Claim Form or go to our website at www.saugus-ma.gov and download a copy of the claim form. Complete all information as requested. Without it we will not be able to process your claim.

Please email the Abandoned Property Claim form to jferraro@saugus-ma.gov and put Unclaimed Property in the subject line or mail the form to the Town of Saugus, Treasurer's Office, c/o Janice Ferraro, Assistant Treasurer/Collector, 298 Central Street, Suite 5, Saugus, MA 01906.

Once your claim form is received, we will review it and issue the proper payment to you with 30-45 days.
