To the Constable of the Town of Saugus

Greetings:

In the name of the Commonwealth of Massachusetts you are hereby required to notify and warn the inhabitants of the Town of Saugus, qualified to vote in Town affairs for the Special Town Meeting at the Saugus Town Hall located at 298 Central Street on **November 28, 2022 at 7:30 PM** to hear and act on the following articles: viz;

**Article 1.** To hear and act on reports of Committees.

**Article 2.** To see if the Town will vote to rescind the vote under Article 2 of the 2022 Annual Town Meeting to appropriate an amount for expenditures not to exceed \$1,500,000.00 from the American Rescue Plan Act (ARPA) as a funding source for Town charges for the ensuing Fiscal Year 2023 and appropriate from the tax levy, local aid, and local receipts an amount not to exceed \$1,500,000.00 as a funding source for Town charges for Fiscal Year 2023. (Town Manager)

**Article 3.** To see if the Town will vote to make supplementary appropriations to be used in conjunction with funds appropriated under Article 2 of the 2022 Annual Town Meeting during the current fiscal year, and determine whether the funds shall be provided by transfer from available funds; or to see what other action the Town wants to take in the matter. (Town Manager)

**Article 4.** To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money for the purpose of funding unpaid bills of a prior fiscal year. (Town Manager)

**Article 5.** To see if the Town Meeting will vote to grant the Town Manager authority to research, develop, and participate in a contract, or contracts, to aggregate the electricity load of the residents and businesses in the Town and for other related services, independently, or in joint action with other municipalities, retaining the right of individual residents and businesses to opt-out of the aggregation, and take any other action relative thereto. (Town Manager)

**Article 6.** To see if the Town will vote to authorize the Board of Selectmen to acquire title to the land and buildings located at 42 Jackson Street, Saugus, MA (Parcel ID 005.E-0017-0006.0) for public parking and other municipal purposes under the provisions of M.G.L. Chapter 40 section 14. (Town Manager)

**Article 7.** To see if the Town will vote to appropriate a sum of money for the purpose of acquiring a parcel of land and buildings thereon located at 42 Jackson Street, Saugus, MA (Parcel ID 005.E-0017-0006.0) including the payment of costs incidental or related thereto; to determine whether this appropriation shall be raised by taxation, transfer from available funds, borrowing or otherwise; or to take any other action relative thereto. (Town Manager)
