Notwithstanding section 10 of chapter 39 of the General Laws and consistent with Chapter 233 of the Acts of 2022 by the Massachusetts General Court and enacted by the Governor on October 5, 2022, the Town of Saugus hereby adopts a new by-law hereby known as Section 211.01, to permit any Town Meeting member to propose a non-binding resolution for consideration by the Town Meeting.

Any Member may submit a written or electronic notice to the Town Clerk, that shall include the proposed language, not less than 48 hours prior to the town meeting, excluding Saturdays, Sundays and holidays.

The Clerk shall promptly notify the Moderator of the Town upon receipt of non-binding resolution and forward the non-binding resolution to Town Meeting Members.

Non-binding resolutions authorized pursuant to this bylaw shall not:

- (i) Appropriate funds;
- (ii) Propose zoning or general by-law changes; or
- (iii) Have any binding effect on the operations of town government.

Non-binding resolutions authorized pursuant to this bylaw shall be considered statements of opinion in accordance with past practice of the Town and shall not be considered as actions of the Town Meeting for purposes of said section 10 of said chapter 39.

Consistent with the criteria set forth, such non-binding resolutions shall be acted upon during the next Town meeting or upon resumption of a Town Meeting that had been temporarily adjourned, whichever comes first; provided, however, that a majority vote of the quorum of the Town meeting shall be required to adopt a non-binding resolution.

This bylaw shall take effect upon its passage.

Peter Manoogian, Precinct 10 speaks at 8:12pm gives formal presentation on the history of this article and why it is before Town Meeting. There had been discussions with current moderator and felt it needed notice. Town Meeting adopted several years ago to ask the State Legislature to grant this bylaw. They wanted weekends to be included and now it's brought back before Town Meeting. This will afford you the smallest town meeting since in 1947 to represent the citizens and keep them informed. Won't be able to appropriate money but can suggest, cannot change any new laws but can suggest, cannot bind the town administration to any action. Finally, nothing to prevent the Town Clerk to facilitate the information.

Ron Wallace, Precinct 5 speaks at 8:21pm in support of the article.

Bill Brown, Precinct 6 speaks at 8:22pm asking if we are required to take some action tonight?

Peter Manoogian PCT 10 you are not required to vote on it, you can table it.

Bill Brown, Precinct 6 his problem is the it shorts out the 48 notice by 11 hours. Two sides to non-binding resolutions. No notice and not able to speak with people. Just leave things the way they are.

Peter Manoogian, Precinct 10 speaks at 8:26pm doesn't understand, these are the exact same hours of other boards and committees. Town Meeting has the right to put off the resolution to the next meeting if you feel not enough time.

Bill Brown Precinct 6 speaks at 8:51pm back in October 24 it was an oncoming resolution to send a letter to the DEP. He listened to a 40-50 presentation and had a discussion on it, motion made to IP. Then had a debate on the IP. When went back to the original article. He called for the question that night with well over an hour discussing this and became repetitive. Each speaker came up over and over. Had other business that night. Has an issue with the 9/10 vote part of the article. That night 2/3s agreed with me. If you vote for this article, plan on spending more time on articles with things that are already said.

Andrew Whitcomb 212 Essex Street, Apt 102, speaking as the only residents here tonight. Been to many of these meetings. Amend the article to show a middle ground without shutting out the public.

Town Moderator explains it is under Roberts Rules when the question is called for after to move the question along.
